Welcome to the Droppii USA Inc. ("Droppii" or "we") platform. Droppii publishes this Privacy Policy to let you know how we collect, use, and disclose your personal while operating our business. It also describes your rights in relation to this information. INFORMATION WE MAY COLLECT ABOUT YOU

As described in greater detail below, Droppii collects personal information—whether it is whole pieces of information or a collection or compilation of bits of information—from range of sources. The most obvious source of information is information you share with us directly. Another source of information is the information automatically collected from your computer when you access our website, mobile application, or other electronic means of communication or data transmission. Finally, we collect about you from third parties.

All of this information is collected to provide you with the best possible services.

Information Collected Directly From You

To use Droppii's marketplace platforms, we require you to provide use certain pieces of personal information: details about yourself (name, date of birth, etc.), means of contacting you (email address, postal address, phone or WhatsApp number, etc.), information necessary for transacting business including financial information (shipping details, purchasing and/or sales history, credit card account information, PayPal and other payment account information, etc.), and additional information that may be necessary to ensure compliance with federal and state law.

We also ask you to create a unique username and password.

Information Collected Automatically

Droppii employs commonly used data collection methods when you communicate with us (electronic platforms or email) or visit our electronic platforms (mobile applications and websites). The following examples are commonly used data collection methods we use:

- We collect information showing your personal interest in our platforms after your online registration with us.
- We collect information regarding your response to marketing campaigns (email, text, etc.).
- We collect information showing the date, time, browser use, and general system or device configuration.
- We collect information regarding your time on our platforms
- We collect IP or similar address information for all electronic visitors to our platforms.

Software and other similar methods such as cookies gather data about you and your browsers for a variety of reasons: (1) enabling use of our electronic platforms, (2) personalizing content on our electronic platforms, (3) delivering relevant advertising according to your interests and likes, and (4) discovering how you use our electronic platforms. Emails may include pixels or gifs to obtain information.

Please note that use of our mobile application may include the use of information collection tools not listed in this Privacy Policy. Any additional disclosures supplement this Privacy Policy without replacing any term or condition.

We record customer calls for internal purposes: quality assurance, compliance, and recordkeeping.

Information Collected From Third Parties

Social media sites are commonly used sources of information through which you may make certain information publicly available: your public profile, family relationships, travel details, other purchases, and organizational affiliations including employment.

Data supplementation services may also be used to increased use of our platforms. To do so, we might acquire names, contact details, financial information, professional and personal affiliations, and demographic information from other sources such as private companies and public registers.

COOKIES AGREEMENT

Droppii USA, Inc. ("Droppii", "we" or "us") owns and operates www.droppiiusa.com, its related web platforms, mobile applications, tools, and other platforms or services

(individually and collectively, the "Platform"). This policy explains how we use cookies on the Platform.

Cookies are small text files that our Platform uses to enable our system to recognize your computer and allow us to see how you use our Platform.

Cookies are often used in conjunction with other internet technologies, such as web beacons, to understand behavior on the internet. For example, Droppii uses cookies in conjunction with web beacons, which are small sections of code that we may place in our Platform to understand the number of unique users that have visited a specific page. Similarly, we may use or receive reporting from tracking scripts that recognize unique cookies issued by another website. These tracking scripts are not used to gather information on your use of the Platform unrelated to the firm, and they do not identify you unless you choose to provide certain personal information to Droppii.

Cookies are not strictly necessary to access our Platform. You may reset your browser to refuse all cookies or to allow your browser to alert you when a cookie is set, however, certain parts of the Platform may function differently and not as well. Unless you have adjusted your browser setting so that it will refuse cookies, the Platform will issue cookies when you logon to it. For more information about how to manage your cookies preferences, you should use the "help" menu of your web browser or explore the customer support sections of your web browser. Please note that you need to configure each browser on each device that you use if you wish to opt-out or block some or all cookies. If you do not wish to receive advertising cookies, you may wish to visit the Network Advertising Initiative (NAI) website by clicking here and the Digital Advertising Alliance (DAA) website here. Further general information about cookies and how they work is available at www.allaboutcookies.org.

The cookies we use on our Platform include:

- 1. Session cookies: These temporary cookies expire and are automatically erased whenever you close your browser window. We use session cookies to grant our users access to content and to enable actions they must be logged in to do.
- 2. Persistent cookies: These usually have an expiration date in the distant future and remain in your browser until they expire or you manually delete them. We use persistent cookies to better understand usage patterns so we can improve the Platform for our customers. For example, we may use a persistent cookie to associate you with your user account or to remember that your choices on the Platform, but this only works when cookies on our Platform are enabled. We do not use technology that recognizes a "do not track" signal from your web browser.

3. Third party cookies: We permit limited third parties to place cookies through the Platform to provide us with better insights into the use of the Platform or user demographics or to provide relevant advertising to you. These third parties may collect information about a consumer's online activities over time and across different web Platforms when he or she uses our Platform. This may include browsing or shopping information.

We may also permit third party service providers to place cookies through our Platform, as indicated above, to perform analytics or marketing functions where you are notified of them, and you have consented to the usage. We do not control the use of such third-party cookies or the resulting information, and we are not responsible for any actions or policies of such third parties.

When you first access the Platform via its website you will receive a message advising you that cookies and similar technologies are in use. By closing the message, or continuing to browse the Platform, you signify that you understand and agree to the use of these technologies, as described in this Cookie Policy. If you prefer not to receive cookies through our Platform, you can set your browser to either reject all cookies, to allow only "trusted" web Platforms to set them, or to accept only those cookies from those Platforms you are currently on (see How to Control Cookies, below). Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you log on to our Platform and use it.

If you refuse cookies, this will limit system performance and may even cause certain features of the Platform to malfunction or not to work at all.
